Setting Our Course

Almost a year ago, the KARL Board of Directors unanimously agreed to delay in-person contact, travel, and its international study tour to the United Arab Emirates, effectively pushing the Program into a third year for this group of KARL Associates. Recruitment of Class XVI was also delayed until 2022.

This was not due to a lack of want, but rather limitations and restrictions that made in-person delivery difficult, costly, and a question of public health and safety. Many Fellows and Associates identified as "essential workers," keeping food in production and delivery of goods and services a constant.

In August 2021, the class reconvened in person with a new seminar, Genesis 2.0, in the Flint Hills of Herington and Council Grove.

No matter what format, the Program continues to focus on its commitment to overall excellence and finding ways to best meet the needs of our state.

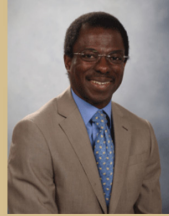

Every day I can depend on the skills KARL provided me to guide me through the corporate decision-making process and help me in the role of a corporate people leader.
